FURTHER RESOLVED, that the resolution be submitted to the electors of the Town for approval or disapproval at referendum to be held Tuesday, November 8, 2016, in conjunction with the election to be held on that date. The Town Clerk is directed to publish notice of the referendum, which shall be incorporated into the notice of said election. The ballot heading for the resolution shall read as follows:

"SHALL THE TOWN OF BLOOMFIELD APPROPRIATE \$11,683,000 FOR

RESOLVED,

(a) That the Town of Bloomfield appropriate ELEVEN MILLION SIX HUNDRED EIGHTY-THREE THOUSAND DOLLARS (\$11,683,000) for costs related to renovations to and expansion of the Town's Public Works Complex located at 21 Southwood Drive in the Town of Bloomfield, contemplated to include renovations to the existing building for shops, maintenance and vehicle storage, an office/employee facility and vehicle maintenance addition, drainage and paving, increased vehicle and material storage, site security and safety measures, removal of underground fuel tanks, a new fueling facility and wash bay, the acquisition of land or easements therein, and related work, improvements, equipment and appurtenances; provided that no portion of the appropriation shall be expended on the acquisition of land, including any easements therein, (other than costs preliminary thereto) until such acquisition has been approved by the Town Council following a report from the Town Plan and Zoning Commission pursuant to Section 8-24 of the General Statutes of Connecticut, Revision of 1958, as amended. The appropriation may be spent for design, construction, acquisition and installation costs, land or easement acquisition costs, equipment, furnishings, materials, utilities, permitting costs, project management including but not limited to a clerk of the works, administrative costs, architects' fees, engineering and other consultant fees, legal fees, net interest on borrowings and other financing costs, and other expenses related to the project or its financing. The Town intends to reimburse the General Fund for preliminary expenditures on the project, including but not limited to costs with respect to related eminent domain proceedings, in an amount not to exceed \$103,000. The Town Council, or such building committee or such other Town officers or officials as are so authorized by the Town Council, is authorized to determine the scope and particulars of the project; and may reduce or modify the scope of the project including the deletion of elements of the project, and the entire appropriation may be spent on the project as so reduced or modified.

(b) That the Town issue its bonds or notes in an amount not to exceed ELEVEN MILLION SIX HUNDRED EIGHTY-THREE THOUSAND DOLLARS (\$11,683,000) to finance the appropriation for the project. The amount of bonds or notes issued shall be reduced by the amount of grants, if any, received by the Town for the project and not separately appropriated to pay additional project costs. The bonds or notes shall be issued pursuant to Section 7-369 of the General Statutes of Connecticut, Revision of 1958, as amended, and any other enabling acts. The bonds or notes shall be general obligations of the Town secured by the irrevocable pledge of the full faith and credit of the Town.

(c) That the Town issue and renew its temporary notes from time to time in anticipation of the receipt of the proceeds from the sale of the bonds or notes and the receipt of grants for the project. The amount of the notes outstanding at any time shall not exceed ELEVEN MILLION SIX HUNDRED EIGHTY-THREE THOUSAND DOLLARS (\$11,683,000). The notes shall be issued pursuant to Section 7-378 of the General Statutes of

Connecticut, Revision of 1958, as amended. The notes shall be general obligations of the Town secured by the irrevocable pledge of the full faith and credit of the Town. The Town shall comply with the provisions of Section 7-378a of the General Statutes if the notes do not mature within the time permitted by said Section 7-378.

(d) That the Town Manager and either the Town Treasurer or the Director of Finance shall sign the bonds or notes by their manual or facsimile signatures. The law firm of Day Pitney LLP is designated as bond counsel to approve the legality of the bonds or notes. The Town Manager and either the Town Treasurer or the Director of Finance are authorized to determine the amount, date, interest rates, maturities, redemption provisions, form and other details of the bonds or notes; to designate one or more bank or trust companies to be certifying bank, registrar, transfer agent and paying agent for the bonds or notes; to provide for the keeping of a record of the bonds or notes; to sell the bonds and notes at public or private sale; to deliver the bonds or notes; and to perform all other acts necessary or appropriate to issue the bonds or notes.


(e) That the Town hereby declares its official intent under Federal Income Tax Regulation Section 1.150-2 that project costs may be paid from temporary advances of available funds and that the Town reasonably expects to reimburse any such advances from the proceeds of borrowings in an aggregate principal amount not in excess of the amount of borrowing authorized above for the project. The Town Manager and either the Town Treasurer or the Director of Finance are authorized to amend such declaration of official intent as they deem necessary or advisable and to bind the Town pursuant to such representations and covenants as they deem necessary or advisable in order to maintain the continued exemption from federal income taxation of interest on the bonds, notes or temporary notes authorized by this resolution if issued on a tax-exempt basis, including covenants to pay rebates of investment earnings to the United States in future years.

(f) That the Town Manager and either the Town Treasurer or the Director of Finance are authorized to make representations and enter into written agreements for the benefit of holders of the bonds, notes or temporary notes to provide secondary market disclosure information, which agreements may include such terms as they deem advisable or appropriate in order to comply with applicable laws or rules pertaining to the sale or purchase of such bonds, notes or temporary notes.

(g) That the Town Council, the Town Manager, the Town Treasurer, the Director of Finance, and other proper officers and officials of the Town are authorized to take any other action which is necessary or desirable to enable the Town to complete the project and to issue bonds, notes or temporary notes to finance the aforesaid appropriation.

(h) That this resolution shall be effective when approved in accordance with the requirements of Section 310 of the Town Charter by majority vote of the qualified electors voting thereon following adoption by the Town Council.

The appropriation may be spent for design, construction, acquisition, installation and demolition costs, equipment, furnishings, materials, utilities, permitting costs, project management including but not limited to a clerk of the works, administrative costs, architects' fees, engineering and other consultant fees, legal fees, net interest on borrowings and other financing costs, and other expenses related to the project or its financing. The Town intends to reimburse the General Fund for preliminary expenditures on the project in an amount not to exceed \$68,000. The Town Council, or such building committee or such other Town officers or officials as are so authorized by the Town Council, is authorized to determine the scope and particulars of the project; and may reduce or modify the scope of the project including the deletion of elements of the project, and the entire appropriation may be spent on the project as so reduced or modified.



2. **Bonnie Bercowetz, 492 Park Avenue,** expressed concerns about forwarding the Human Services building to bond referendum, due to the process in receiving public input and more of a vetting process. Ms. Bercowetz provided a programming report for future Senior/Community Center from the Town of Simsbury, referencing information from multiple sources and stakeholders about the need and viability on plans for a new center.
3. **Joseph Suggs, 10 Sandpiper Drive,** expressed his support in building a new facility for Human Services. He stated that this is the best option for the community in providing the greatest benefit for most residents. A new building would provide space for three town departments, to serve the public more practically, provide a higher level of safety and security.
4. **Rickford Kirton, 7 Hickory Lane,** reiterated the need to solicit public interest, feedback and support from concerned citizens. He also commented on the importance of both projects and stated that the library is not obsolete and children enjoy what the services libraries they provide.
5. **Mark Shapiro, 8 Hampton Lane,** Bloomfield Citizens.org urge the Town Council, individual or group to consider the best interest in better government and advocacy of its citizens.

6. **Bradley Klein, 82 Tariffville Road,** seeking response from Council about public comment at the end of Town Council meetings. The public deserves more information and to be taken seriously. He suggested to hold a public meeting once a month for this purpose. This would provide an opportunity for an informed debate. Mr. Klein also commented on a very important issue regarding the complex needs of 330 Park Avenue. Having casual observations with citizens and citing abstract statistics of dangers in the building is not a basis for policy making.
7. **Sharon Mann, 1 Adams Road,** Bloomfield Citizens.org fully support Senior Services, Leisure Services and Social & Youth Services. The town needs to perform better due diligence regarding a new building for 330 Park Avenue, whether it should provide space for disaster services, some services located elsewhere, and whether or not the plans represent the latest, professional and contemporary thinking about how services are being delivered. Do not support funding for a project that has not been fully vetted.
8. **Margot Hennebach, 13 Pent Road,** expressed concerns about the process and how each bond referendum proposal was flawed as each were governed by different rules. She further described library building committee process, in comparison to 330 Park Avenue proposal and presentation.
9. **Jane Biral, 10 Pent Road,** noted that since 2012, the town has spent approximately \$78,000 to develop plans to update the library. It's not about the failure to utilize taxpayer money appropriately. It's about giving citizens the new library is what they deserve.
10. **Robert Berman, 8 Hiram Lane,** commented on three capital building projects and the limit of debt capacity for the town. He provided table of analysis of debt service and tax abatements for years 2016-2025. (see attached)
11. **Kenneth McCleary, 77 Wintonbury Avenue** stated his support for a new building at 330 Park Avenue. He stated that this conditions of this building is a public safety issue. Mr. McCleary expressed his concerns and commented on the significant changes with the future of library, technology and overall interest for the community.
12. **David Mann, 1 Adams Road** stated that facts are needed for improvements to 330 Park Avenue. There should be more evaluation of programs and plans for a new facility.
13. **Mark Weisman, 5 Pent Road** clarified comments made by Mr. Berman regarding designs of the water course would not be delayed or comprised with a lengthy approval process by the Army Corp of Engineers. He also clarified that the library building committee did is not seeking to acquire the property to the north based on the new proposal of obtain the Riley Lumber property.

14. **Donna Landerman, 6 Rundelane** support the library and services provided at the 330 Park Avenue. However, she does not support how the Council set up citizens in town to be controversial with one another. She would like the town to work together and expressed disappointment with town leadership and its actions regarding the process in evaluating the library and the human services building renovations.

15. **Joseph Merritt, 31 Woods Road** commented on the urgency of all of the safety concerns at 330 Park Avenue to be addressed from the current town budget.

Mayor Gamble informed the citizenry that the Council has decided to appoint a building committee for the Alvin & Beatrice Wood Human Services Center located at 330 Park Avenue. This building committee will scheduled public meetings for input and suggestions. She also commented on significant changes within public libraries with electronic media, etc. Mayor Gamble reiterated the need to provide necessary and improved library services for residents. This project will be reconsidered in the near future.

### **REPORT FROM COUNCIL SUBCOMMITTEES**

Community Services – Councilor Seldon listed several announcements from Leisure Services, and Social & Youth Services. The Annual West Indian Festival will be held on Thursday, August 4, 2016. The Annual Back to School Fun Fair will be held on Saturday, August 20, 2016 from 10:00 a.m. – 2:00 p.m. Community Conversation of Race Forum will be held on Tuesday, August 9, 2016 at 6:00 p.m.

Golf – Councilor Rivers commented on a renewed interest in walking trails around the golf course. These concerns will be handled by the Wintonbury Land Trust and Leisure Services during the development of a connectivity plan.

Finance – Councilor Hypolite clarified debt capacity projections, grand list growth, debt per capita, overall climate in tax increases, projected \$30 million debt cap without significantly increasing taxes.

Public Safety – Councilor Washington read a brief subcommittee report of the last meeting held on July 11, 2016.

Committee on Committees – This subcommittee report was deferred for discussion under Council agenda items.

Land Use & Economic Development – The meeting scheduled for Monday, August 15, 2016 at 7:00 p.m. will be cancelled.

**It was moved by Councilor Hypolite, seconded by Councilor Washington to amend the public hearing date in accordance with Section 307 of the Town Charter on Monday, August 8, 2016 at 7:35 p.m. in the Council Chambers, Town Hall, 800 Bloomfield Avenue in Bloomfield; and that the Town Manager, the Town Clerk and the Clerk of Council are hereby directed to provide due and legal notice of such public hearing.**

Councilor Hypolite stated that Centerbrook Architects & Planners did comply with the Request for Proposal detailing a programmatic review and space planning analysis to develop conceptual plans and project estimates. He also stated that there are some significant issues that need to be addressed at 330 Park Avenue. Councilor Hypolite also inquired about the timing, process and level of confidence for Centerbrook Architects to complete this project.

It was noted that the Bloomfield community has a history of appointing a building committee in the initial process. Councilor Hypolite asked Centerbrook Architects their opinion regarding a preferred process compared to the Construction Manager process. It was also asked if a building committee is appointed, what more information can be obtained from the public and how would this information co-exist with the Construction Manager as one entity. It was noted that the building committee would be an advocate and representative for the town. The construction manager would monitor and maintain cost for the total project.

Councilor Rivers suggested a review of the project timeframe. He reiterated completion of the initial phase in working with town staff and developing a space and program analysis for 330 Park Avenue.

Councilor Washington inquired about the level of commitment from Centerbrook Architects to achieve set goals in building construction.

Councilor Seldon stated that there was a review of conceptual designs initially cost estimates presented. He stated that the community has an opportunity to design the building through participation with the building committee. The Construction Manager is the expert to determine cost management of the overall project.

Deputy Mayor Schulman also inquired about Centerbrook Architects availability to meet with the building committee, subcommittees and other interested community partners.

Mr. Lavy indicated that the RFP states Centerbrook moving forward and enter into the design phase of the project.

The public present at this meeting expressed the following concerns:

- Public comment and questions are not allowed during Council discussions, the Centerbrook updated presentation should have been addressed at the beginning of the meeting prior to Citizen Statements & Petitions.

Councilor Hypolite requested clarification that the specific language was approved and vetted by the bond counsel.

Mr. Doug Gillette, Bond Counsel from Day & Pitney stated that at the July 11, 2016, the Town Council meeting, the bond resolution was introduced and the public hearing set for 330 Park Avenue was tabled.

Once this resolution is taken off of the table, then Council could act, followed by any amendments regarding the particulars of appropriation bonding authorization amount. An adjustment for the new public hearing date must be established.

Deputy Mayor Schulman clarified details about previous studies on library being abandoned. He noted that both projects will go forward, not which one but when. If the bond referendum is passed in November, this motion addresses the issue bonds for 330 Park Avenue. This is not a final decision, it only to authorize to sell bonds.

Bonnie Bercowetz, 492 Park Avenue asked why this project is being proposed for referendum this November 2016. It should be delayed to further explore options and public input.

Mayor Gamble stated that no referendum on the library received majority support based on issues with land acquisition.

Councilor Merritt expressed disappointment in ruling out the library project as an option. He suggested to wait for another five years and propose both projects.

Bradley Klein, 82 Tariffville Road stated that Centerbrook must go through the RFP process for competitive bidding.

*Jane Nadel-Klein, 82 Tariffville Road* asked about the purpose for a public hearing for this project. She stated that the building committee should be formed and public input considered prior to the bond referendum being proposed and voted on.

Mr. Gillette clarified the public hearing date for the Alvin & Beatrice Wood Human Services Center to be scheduled for Monday, August 8, 2016.

(a) That the Town of Bloomfield appropriate TWENTY MILLION EIGHT HUNDRED NINETEEN THOUSAND DOLLARS (\$20,819,000) for costs related to the design, construction, furnishing and equipping of a human services facility to be located at 330 Park Avenue in the Town of Bloomfield, contemplated to include the demolition of the existing approximately 92,000 square foot building on the site and the construction of an approximately 52,419 square foot facility providing programming space for the Town's Leisure Services,

Senior Services and Social and Youth Services Departments and their activities, including a gymnasium, multipurpose rooms, a food bank and kitchen, site improvements, including but not limited to parking, traffic flow, lighting, security and landscaping, and related work, improvements, equipment and appurtenances. The appropriation may be spent for design, construction, acquisition, installation and demolition costs, equipment, furnishings, materials, utilities, permitting costs, project management including but not limited to a clerk of the works, administrative costs, architects' fees, engineering and other consultant fees, legal fees, net interest on borrowings and other financing costs, and other expenses related to the project or its financing. The Town intends to reimburse the General Fund for preliminary expenditures on the project in an amount not to exceed \$68,000. The Town Council, or such building committee or such other Town officers or officials as are so authorized by the Town Council, is authorized to determine the scope and particulars of the project; and may reduce or modify the scope of the project including the deletion of elements of the project, and the entire appropriation may be spent on the project as so reduced or modified.

(b) That the Town issue its bonds or notes in an amount not to exceed TWENTY MILLION EIGHT HUNDRED NINETEEN THOUSAND DOLLARS (\$20,819,000) to finance the appropriation for the project. The amount of bonds or notes issued shall be reduced by the amount of grants, if any, received by the Town for the project and not separately appropriated to pay additional project costs. The bonds or notes shall be issued pursuant to Section 7-369 of the General Statutes of Connecticut, Revision of 1958, as amended, and any other enabling acts. The bonds or notes shall be general obligations of the Town secured by the irrevocable pledge of the full faith and credit of the Town.

(c) That the Town issue and renew its temporary notes from time to time in anticipation of the receipt of the proceeds from the sale of the bonds or notes and the receipt of grants for the project. The amount of the notes outstanding at any time shall not exceed TWENTY MILLION EIGHT HUNDRED NINETEEN THOUSAND DOLLARS (\$20,819,000). The notes shall be issued pursuant to Section 7-378 of the General Statutes of Connecticut, Revision of 1958, as amended. The notes shall be general obligations of the Town secured by the irrevocable pledge of the full faith and credit of the Town. The Town shall comply with the provisions of Section 7-378a of the General Statutes if the notes do not mature within the time permitted by said Section 7-378.

(d) That the Town Manager and either the Town Treasurer or the Director of Finance shall sign the bonds or notes by their manual or facsimile signatures. The law firm of Day Pitney LLP is designated as bond counsel to approve the legality of the bonds or notes. The Town Manager and either the Town Treasurer or the Director of Finance are authorized to determine the amount, date, interest rates, maturities, redemption provisions, form and other details of the bonds or notes; to designate one or more bank or trust companies to be certifying bank, registrar, transfer agent and paying agent for the bonds or notes; to provide for the keeping of a record of the bonds or notes; to sell the bonds and notes at public or private sale; to deliver the bonds or notes; and to perform all other acts necessary or appropriate to issue the bonds or notes.

(e) That the Town hereby declares its official intent under Federal Income Tax Regulation Section 1.150-2 that project costs may be paid from temporary advances of available funds and that the Town reasonably expects to reimburse any such advances from the proceeds

The Town shall comply with the provisions of Section 7-378a of the General Statutes if the notes do not mature within the time permitted by said Section 7-378.

(d) That the Town Manager and either the Town Treasurer or the Director of Finance shall sign the bonds or notes by their manual or facsimile signatures. The law firm of Day Pitney LLP is designated as bond counsel to approve the legality of the bonds or notes. (e) That the Town hereby declares its official intent under Federal Income Tax Regulation Section 1.150-2 that project costs may be paid from temporary advances of available funds and that the Town reasonably expects to reimburse any such advances from the proceeds of borrowings in an aggregate principal amount not in excess of the amount of borrowing authorized above for the project. The Town Manager and either the Town Treasurer or the Director of Finance are authorized to amend such declaration of official intent as they deem necessary or advisable and to bind the Town pursuant to such representations and covenants as they deem necessary or advisable in order to maintain the continued exemption from federal income taxation of interest on the bonds, notes or temporary notes authorized by this resolution if issued on a tax-exempt basis, including covenants to pay rebates of investment earnings to the United States in future years.

(f) That the Town Manager and either the Town Treasurer or the Director of Finance are authorized to make representations and enter into written agreements for the benefit of holders of the bonds, notes or temporary notes to provide secondary market disclosure information, which agreements may include such terms as they deem advisable or appropriate in order to comply with applicable laws or rules pertaining to the sale or purchase of such bonds, notes or temporary notes.

(g) That the Town Council, the Town Manager, the Town Treasurer, the Director of Finance, and other proper officers and officials of the Town are authorized to take any other action which is necessary or desirable to enable the Town to complete the project and to issue bonds, notes or temporary notes to finance the aforesaid appropriation.

(h) That this resolution shall be effective when approved in accordance with the requirements of Section 310 of the Town Charter by majority vote of the qualified electors voting thereon following adoption by the Town Council.
