KINDERGARTEN Registration is Now Open for 2025-2026 School Year



Register by August 4th to ensure busing for the first day of school. Your child must be 5 years old by September 1st, 2025 to enroll**. We will have an Open House in February and April. Start the registration process to receive email notification and Open House information.



** Recent legislative changes to the Kindergarten starting age Public Act 23-208 states that beginning with the 2024-2025 school year, all children attending kindergarten must turn 5 on or before September 1st of that school year. For students previously eligible to begin kindergarten, the legislation provides a provision that a child may be considered to attend kindergarten if:

- (1) A parent submits a written request to the principal, and
- (2) The school district completes an assessment that supports the child is developmentally ready for kindergarten.






Mayor Danielle C. Wong praised the department's contributions, stating, "Public Works is the backbone of

ASSESSOR INFORMATION

ELDERLY & DISABLED HOMEOWNERS TAX RELIEF

This program is for Elderly & Disabled Homeowners that meet the required qualifications listed below. The benefit is reflected in a reduction to the annual Real Estate taxes on a primary residential property.

Homeowners Tax Relief

Requirements

- Driver's license or birth certificate showing that you or your spouse must have been 65 years of age by December 31, 2024
- File between February 1, 2025 and May 15, 2025
- If you are not 65, you must be over 18 and social security disabled; you must submit a recent TPQY printout from Social Security indicating that you are a disabled individual and the date which the disability began

Maximum income:

- Single - \$45,200
- Married - \$55,100

Proof of all 2024 income (qualifying income is total income for IRS plus Social Security income including Medicare):

- Bank interest
- Pension
- Social Security (including Medicare)
- Any other income from 2024

In order for us to process your claim, a copy of your 2024 SSA 1099 Form must accompany your application. If you file a 2024 federal income tax return, we must have a copy.



ANNUAL INCOME & EXPENSE FORMS DUE JUNE 1

Connecticut General Statutes Section 12-63c requires owners of income generating property to annually file by June 1st.

The information filed and furnished with this report will remain confidential in accordance with Section 12-63c(b), which provides that actual rental and operating expenses shall not be a public record and is not subject to the provisions of Section 1-210 (Freedom of Information).

These forms will be mailed out to prior applicants on or before April 17th. Any new owner of an income generating property may obtain the updated form on the assessor's website after April 1st.

Each summary page should reflect information for a single property for the calendar year 2024. If you own more than one rental property in the

Town of Bloomfield, a separate report must be filed for each property. An income and expense report summary page and the appropriate income schedule must be completed for each rental property. **Forms can be submitted via email to assessor@bloomfieldct.gov.**

FISHING & DOG LICENSE AVAILABLE THROUGH THE TOWN CLERK'S OFFICE



Anyone over the age of 16 is required to obtain a fishing license, available in the Town Clerk's Office. No license is required for youth under the age of 16, as long as they are accompanied by an adult who holds a current fishing license. A list of fees can be found on the Town Clerk's webpage. Connecticut residents over the age of 65 can receive a license at no fee. The Trout and Salmon stamp is required for anyone fishing in a Trout Management Area, Wild Trout Management Area, Trout Park, or Atlantic Salmon Broodstock Area, and the cost is \$5.00.



All dogs 6 months and older must be licensed in the town in which they reside. All dogs shall be licensed in the month of June or penalties apply. Beginning July 1, there is a \$1.00 registration penalty for each month that a dog has been unregistered. Licenses may be obtained provided that you have a current rabies certificate and a verification of your dog having been neutered or spayed, if applicable. The fee for a spayed/neutered dog is \$8.00, and the fee for a non-spayed/non-neutered dog is \$19.00.

April 1 - September 30, 2025

Maximum Income:

Single: \$ 45,200

Married: \$ 55,100

REQUIREMENTS FOR RENTER'S REBATE:

- 1) You must have rented in Connecticut between January and December 2024.
- 2) Your total gross income can not exceed the guidelines listed above.
- 3) You or your spouse must be 65 years of age or older OR receiving Social Security Disability benefits or other disability benefits and show proof of disability.
