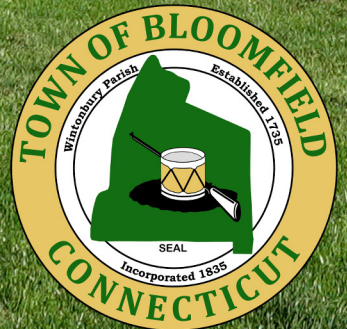

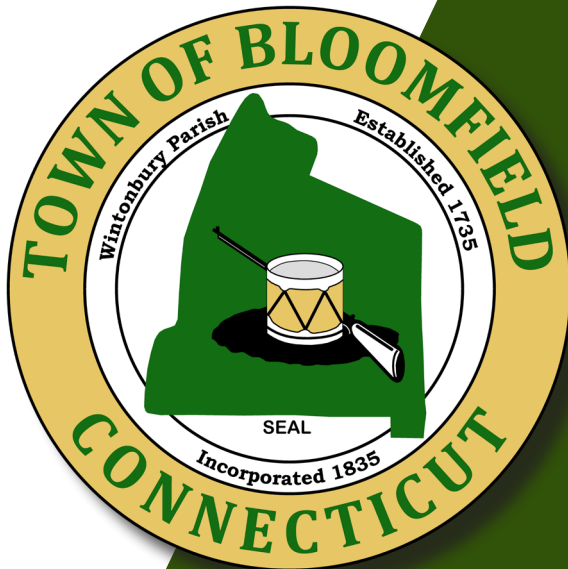

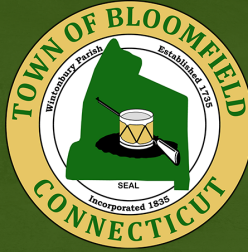
A Season of Gratitude

2024 REVALUATION

IT'S IMPORTANT TO REMEMBER....

Your 2024 assessment will be mailed to you in November, and the mill rate is not set until May of 2025. There is no way to determine the amount of your individual taxes until the mill rate is adopted by the Town Council at the Annual Town Meeting.

THE PURPOSE OF A REVALUATION

The main purpose of a revaluation is to develop accurate and uniform assessments of real estate, based on fair market value. This, in turn, will generate an equitable tax base throughout the town and ensure that the tax burden will be fairly distributed among Bloomfield taxpayers. A revaluation is a revenue neutral process. Meaning that the amount of taxes the town needs to collect is based on the budget, regardless of whether or not a revaluation takes place. What is likely to change is the amount of taxes individual taxpayers pay, based on the property value shifts that occur every five years.

HOW A PROPERTY REVALUATION IS CONDUCTED

In accordance with Connecticut General Statutes, the Town of Bloomfield is conducting a real property revaluation as required for the Grand List of October 1, 2024. This revaluation will correspond to the tax bills that will be due beginning in July 2025. Property information will be obtained from inspections, data mailers, building permits, sales verifications and data analysis.

THE REVALUATION PROCESS

Revaluation is a long process required by state law, one that will take almost two years to complete from the start of the process to the payment of the first tax bills after the revaluation.

This process began in mid-2023 when the Town of Bloomfield undertook a Request for Proposal to solicit proposals from state certified revaluation firms. The company selected was Vision Government Solutions Inc. (Vision) of Hudson, Massachusetts. Vision also performed Bloomfield's revaluation in 2019. They have been in business for over 35 years and have performed over one hundred Connecticut revaluations. Some of Vision's senior-most staff have been involved in Bloomfield's 2024 revaluation.

INFORMAL AND FORMAL APPEAL HEARINGS

In November 2024, property owners will receive a notice of their new assessment. All assessments will be available online to allow taxpayers to view surrounding properties. Taxpayers may request an informal hearing with Vision staff members if they wish to discuss their new assessments. The informal hearing is the first step in the appeal process if the property owner feels their assessment is inaccurate. The informal hearings will take place in November/December 2024. Anyone who participated in the informal hearings will receive another assessment notice in early 2025.

Owners who wish to appeal their assessment will have the opportunity to do so at a Board of Assessment Appeals hearing. This formal appeal process is undertaken annually guided by state statute.

After all five phases are completed, all data, files, records, etc. used in the revaluation will be given to the Assessor's Office. This will allow the town to maintain the data collected and values determined during the revaluation on a continual basis.

WHAT DO THE TERMS MILL RATE AND GRAND LIST MEAN?

A **mill rate** (or millage rate) is a number that represents how much tax is levied on a property for every \$1,000 of its assessed value. For example, if the mill rate is 30, \$30 of property tax will be charged for every \$1,000 of a property's assessed value.

The **grand list** is the net taxable assessed value of all the property in the town. This includes property such as private residences, private vehicles, business personal property and commercial property. In Connecticut, the net taxable assessed value of an asset is determined as 70% of the property's fair market value.

DROP-IN ADULT PICKLEBALL

Treat or treat safely by carrying a flashlight and be on alert for vehicles.

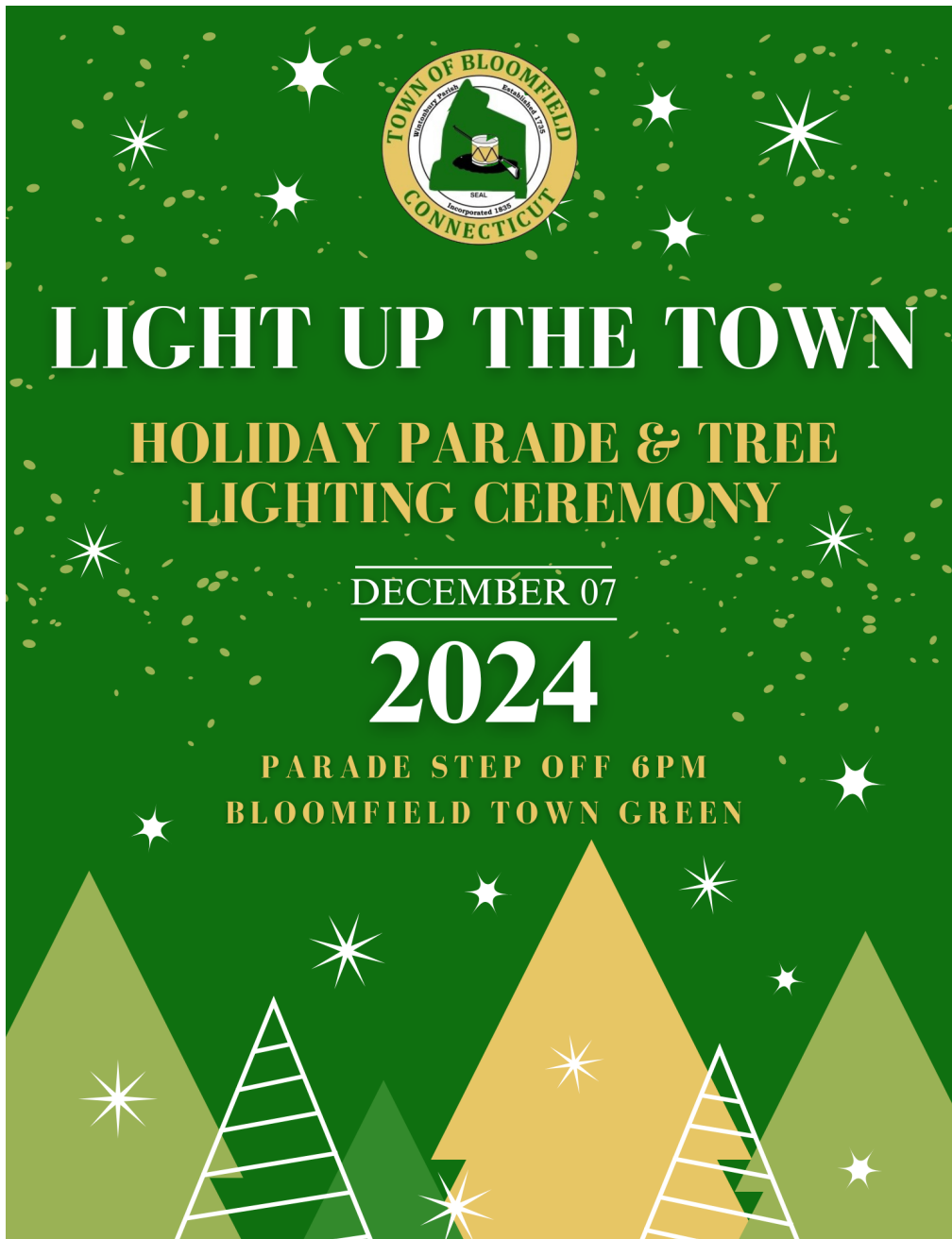
FITNESS CLASSES FOR ADULTS

SAFETY TIPS FROM BLOOMFIELD CENTER & BLUE HILLS FIRE DISTRICTS

As the leaves turn from green to orange, the weather cools, and you start preparing for the cold season ahead. You're excited about the approaching holiday season and can't wait to start decorating your home. But have you thought about the fire safety risks that arise during the fall and winter months?

CHANGE SMOKE/CARBON DETECTOR BATTERIES AND TEST THE ALARMS

You should have a minimum of one smoke/carbon monoxide detector on each level of your home.

When Daylight Savings Time begins and ends, it's a good idea to change your smoke and carbon monoxide detector batteries. This ensures the alarms don't fail when you turn the heat on in your home.

Check that all fire extinguishers are in working order when you adjust the clocks each season.

FULLY CHECK AND SERVICE YOUR HEATING DEVICES BEFORE CRANKING UP THE HEAT:

Have your furnace inspected, cleaned, and serviced by a certified HVAC contractor.

If you use space heaters, ensure there is at least three feet of space around them. Don't place fabrics on space heaters to dry and turn heaters off when going to bed.

Have all alternative heating sources such as a wood stove examined by an expert to ensure they function properly.

Clean and check fireplaces and chimneys regularly – burn only seasoned wood and avoid soft wood like pine which creates a build-up of creosote in the chimney, which is the leading cause of chimney fires. Be sure to open the damper before starting a fire. A closed damper can cause excess smoke and gas to be released into your home almost immediately after starting a fire.

CANDLE SAFETY

If you exit the room, extinguish the flame. Never leave a burning candle unattended.

Place candles at least 12 inches away from other highly combustible items, such as decorations, drapes, and furniture.

Candleholders should be sturdy and difficult to tip over, and the surfaces on which they are placed should be clear of clutter.

OUTDOOR FIRE RISKS

As leaves and other flammable debris build up around your home, make it a habit to remove them periodically.

Prune trees and rake up leaves and twigs.

Keep your roof, gutters, and downspouts clear of debris, and remove fuel from lawnmowers before storing them for winter.

Don't store fuel in your home or garage.

GENERATORS

Portable generators are useful during power outages.

Generators and fuel should always be used outdoors and at least 20 feet away from windows, doors, and attached garages. Keep the generator dry and protected from rain or flooding. Touching a wet generator or devices connected to one can cause electrical shock.

Always connect the generator to appliances with heavy-duty extension cords.

Let the generator cool before refueling. Fuel spilled on hot engine parts can ignite.

BLOOMFIELD CENTERED & STRONG TOWN CENTER PLAN

Town of Bloomfield Mayor Danielle C. Wong and James Michel, Town Center Economic Development Commission (TCEDC) Chairperson are pleased to announce that East Hartford-based, Goman York Property Advisers LLC (Goman+York) has been selected to lead the Town through the process of developing the Bloomfield Centered and Strong Town Center Plan. This development plan was made possible through a Community Investment Fund 2030 (CIF) Grant award by Governor Ned Lamont, the CIF Board, and the State Bond Commission. The plan will identify a broad range of projects and strategies with the goal of creating a cohesive plan that will serve as a roadmap to the future for Bloomfield's Town Center.

"We were honored that Bloomfield was awarded this CIF grant which allows us to plan for a vibrant community center for our future generations. The kick-off will be the first of many opportunities for our community members to engage in shaping Bloomfield's future," said Mayor Wong. "I also encourage our residents to take part in the community survey that runs through October 15 which you can access through the Town's website. This gives everyone in our community a voice to make our Town Center a place to be proud of."

"The plan will involve developing systematic tactics to identify short- and long-term projects that will benefit our community, residents, businesses, and visitors," James Michel stated. "The

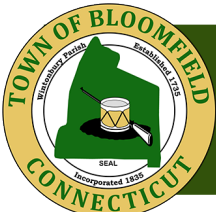
projects identified through this plan will build upon each other and the excitement already taking place to make Bloomfield Town Center a stronger community hub for all."
