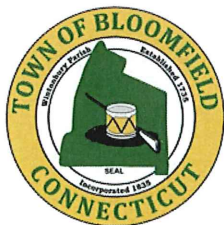
Hi Lynda,

We only show one business – M&M Construction & Landscaping doing business as Drainage Pros listed on our business personal property records for 69 Brown. They have been on our list since 2016 when they were located at 49 Brown. They have never filed the required annual business personal property declaration, except for one late filing in 2022. All years besides 2022 were Non-Filed meaning the business owner did not file the required annual declaration.

When the statutorily required declaration of business personal property is NOT filed the in assessor's office by a business owner, then the assessor applies an estimated assessment to their account which generates the annual business personal property tax billing for that business.

There has been a business personal property tax declaration filing reminder letter, as well as tax bills mailed annually to Drainage Pros since 2016, first to 49 Brown and then to 69 Brown St. Not one of those bills has ever been paid (see attached) and all but one year (2022) no declaration was ever filed in our office. Over the years statutorily required monthly penalties and interest are added by the tax collector's office to the unpaid balance of each past due tax bill. The attached is an accounting of all the unpaid tax bills.

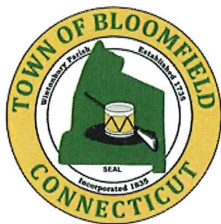
