TOWN OF BLOOMFIELD SUMMER HOURS PILOT PROGRAM

Beginning July 7, 2025, the Town of Bloomfield will launch a 60-day pilot program to revise in-person hours at **Town Hall** (800 Bloomfield Avenue) and the **Alvin & Beatrice Wood Human Services Center** (330 Park Avenue). These changes are designed with residents in mind to provide more flexible access to services while maintaining overall service availability.

There will be no impact to core services—The Department of Public Works, Bloomfield Police Department, and Bloomfield Public Library will continue operating on their regular schedules.

UTILITY MATCHING PAYMENT PROGRAM

The Matching Payment Program (MPP) can lower the amount you owe on energy bills. For every dollar you pay and every dollar you receive from the Connecticut Energy Assistance Program (CEAP), Eversource and CNG will subtract a dollar from the amount you owe up to a zero balance.

Bloomfield's Food Bank is available to Bloomfield Residents. Fill out an application and provide proof of Bloomfield residency. There are two visits per month allowed per household. **It is open Wednesdays from 1 pm – 3 pm and Fridays 11 – 1pm. Starting July Fridays will be from 10 am – noon.** Once a month there is a shopping day, which counts as 1 of your 2 monthly visits. Shopping Day is by appointment only as space is limited. Please call on the first business day of each month 860-242-1895 to make an appointment.

RENTER'S REBATE PROGRAM

This rebate is available to Connecticut renters who are 65 years of age or older; or under 65 years of age and receiving social security disability.

Filing Period runs through Sept. 30th

Maximum Gross Income

Single Person: \$45,200

Married Couple: \$55,100

Required documents:

- 1) *your SSA 1099*
- 2) *2024 tax return (if one was filed)*
- 3) *2024 rent payment history*
- 4) *2024 utility payment history*
